

Invitation to roundtable and conference:

"Diaspora engagement in the EU"

Over 34 million persons born in a third country live in the European Union, representing 6.9 percent of its total population. Their active participation in the society, apart from the integration in the labor market, is key to maximizing their opportunities, welfare and dignity, which will contribute to development of the EU. To promote the efficient management of migration flows and the implementation, strengthening and development of a common Union approach to asylum and immigration, the EU established the Asylum, Migration and Integration Fund (AMIF) in 2014. The transnational project "We all need new engagement!" (WANNE), funded through EUAMIF, attempted to foster the engagement of third country nationals in the communities of the receiving countries. 15 partners from seven EU member states, including, Austria, Croatia, Greece, Italy, Malta, Romania, and Slovenia, supported the educational, cultural and social activities of the diaspora and migrants in their communities.

Representatives from the EU parliament, the commission, experts, the project partners and the diaspora organizations will take part in a round table and conference to take stock of the status quo of the diaspora engagement within the EU and discuss following questions:

- What are the major challenges facing the diaspora engagement within their communities in the EU
- How are NGOs and diaspora organizations addressing these challenges?
- What are the potential areas of engagement with diaspora within the EU
- What are the missing links in harnessing the benefits of diaspora engagement within the EU?
- How can the EU support the member states, NGOs and diaspora organizations?
